OBJECTS AND REASONS

This Bill is the *Final Appropriation Bill* in respect of the Financial Year which ended on the 31st March 2008 and would provide for the grant out of the Consolidated Fund of the sum of \$888,528,350 and for the appropriation of that sum for the services and purposes specified in the Schedule.

BARBADOS

A Bill entitled

An Act to grant an additional sum of money out of the Consolidated Fund and to appropriate the same for the services of the Island for the Financial Year that ended 31st March, 2008.

WHEREAS the sum of money granted out of the Consolidated Fund by the *Appropriation Act*, 2007 for the services of the Island for the Financial Year ended 31st March, 2008 has proved insufficient to meet the demands for such services; **AND WHEREAS** certain Resolutions were passed during the Financial Year that ended 31st March, 2008 granting additional sums out of the Consolidated Fund for the services of that year, and it is deemed expedient to appropriate the same in the manner hereinafter mentioned;

NOW THEREFORE BE IT ENACTED by the Parliament of Barbados as follows:

Short title.

1. This Act may be cited as the *Final Appropriation* (2007-2008) *Act*, 2008.

Supplementary grant of \$888,528,350

2. The Accountant General may, on the warrant of the Minister or some person authorised by the Minister in writing, issue out of the Consolidated Fund and apply for making good the sums granted for the supply of services for the year ended 31st March, 2008 the sum of eight hundred and eighty-eight million, five hundred and twenty-eight thousand, three hundred and fifty dollars.

Date on which grant takes effect. 3. The sum granted by this Act shall be deemed to have been granted on the 1^{st} April, 2007 in addition to the sum granted by the *Appropriation Act*, 2007.

Appropriation of sum granted.

Schedule

4. The sum granted by this Act out of the Consolidated Fund for making good the sums granted for the purpose specified in section 2 is appropriated from the 1st April, 2007 for the purposes specified in the *Schedule*.
