ALL THAT land, the property of the Crown situate at the Ivy in the parish of Saint Michael in this Island containing by admeasurement 17,295.7 square metres or thereabouts (inclusive of 449.9 square metres in road) Abutting and Bounding on lands now or formerly of the Estate of Agusta Blenman'deceased, on lands now or late of Naman Herbert, on lands now or late of Antoinette Delores Cadogan, on the public road known as Hoyte's Road, on lands now or late of Steve Yarde, on lands now or late of Sydney Jones, on lands now or late of Granville Small, on lands now or late of Juke Forde on lands now or late of Tina Payne on the public road known as Government Hill, on lands now or formerly of H. Tudor, on a road, on lands now or late of Grantley Beckles, on lands now or late of Mohamed Farook et al on lands now or late of Michael Newton, on lands now or late of Thelma Jones on lands now or late of Edwin Thompson and on the public road known as Ivy Road or however else the same may abut and bound as is shown and delineated on a plan certifed on the 20th day of March by O'Brian St. E Worrell, Land Surveyor and recorded in the Lands and Surveys Department on the 26th day of March, 2007 as Plan No. 373/2007.

ADDENDUM

On the 17th day of July, 1980, the Crown acquired 17,303.55 square metres of land situate at the Ivy in the parish of Saint Michael in this Island in accordance with the *Land Acquisition Act*, Cap. 228 for housing development by virtue of Statutory Instrument No. 100 of 1980.

The said parcel of land was subsequently surveyed and was found to contain by admeasurement 17,295.7 square metres of land as is shown and delineated on a plan certified on the 20th day of March by O'Brian St. E Worrell, Land Surveyor and recorded in the Lands and Surveys Department on the 26th day of March 2007 as Plan No. 373/2007.

On the 1st day of October 2009, the Cabinet agreed to the vesting of the said 17,295.7 square metres of land more particularly described in the *Schedule* hereto in the National Housing Corporation for housing development.

The aforementioned Plan shows that there is an encroachment on the said parcel of land which the National Housing Corporation had agreed to accept and undertakes to remedy the same.

In accordance with the provisions of section 5 of the *Crown Lands (Vesting and Disposal) Act*, Cap. 225, the approval of The Parliament is now sought for the vesting in the National Housing Corporation of the parcel of land described in the *Schedule* of this Resolution.
