**ADDENDUM**

The *Senate and House of Assembly (Remuneration and Allowances of Members) Order, 2007* has been laid in Parliament.

The Order provides for a first increase in the salary of the President of the Senate with effect from 1st September, 2004, a second increase with effect from 1st April, 2005, a third increase from 1st April, 2006 and a fourth increase from 1st April, 2007.

The Order also provides for a first increase with effect from 1st April, 2006 and a second increase from 1st April, 2007 of the duty allowances paid to the President of the Senate, the Deputy President and other Senators.

In addition, the Order makes provision for a first increase with effect from 1st April, 2006 and a second increase from the 1st April, 2007 of the salaries and allowances paid to the Speaker, Deputy Speaker, Chairman of Committees, Leader of the Opposition and other members of the House of Assembly.
