# CIVIL ESTABLISHMENT (TEACHERS) (AMENDMENT) ORDER, 2007

The Minister in exercise of the powers conferred on him by section 2 of the Civil Establishment Act, makes the following Order:

- 1. This Order may be cited as the Civil Establishment (Teachers) (Amendment) Order, 2007.
- 2. The Civil Establishment (Teachers) Order, 1999, is amended S.I. 1999 by deleting Schedules A to H and substituting Schedules A to H as No. 70. contained in the Schedule to this Order.
- 3. The emoluments specified in Schedules A to H are payable in respect of the offices to which they relate as follows:
  - (a) in respect of the emoluments specified in the first column, with effect from 1st April, 2006; and
  - (b) in respect of the emoluments specified in the second column, with effect from 1st April, 2007.
