**JUDGES REMUNERATION AND PENSIONS
(CONDITIONS OF SERVICE AND ALLOWANCES)
(AMENDMENT) REGULATIONS, 2007**

The Governor-General in exercise of the powers conferred on him by section 16 of the *Judges Remuneration and Pensions Act*, makes the following Regulations:

1. These Regulations may be cited as the *Judges Remuneration and Pensions (Conditions of Service and Allowances) (Amendment) Regulations, 2007*.

2. Regulation 15 of the *Judges Remuneration and Pensions (Conditions of Service and Allowances) Regulations, 1969* in these Regulations referred to as the principal Regulations, is amended by deleting paragraph (b) and substituting the following: S.I. 1969
No. 148.

"(b) to be paid a transport allowance at the following rate:

- (i) \$10 075, with effect from 1st April 2006; and
- (ii) \$10 327, with effect from 1st April 2007."

3. The principal Regulations are amended by deleting the Schedule and substituting the *Schedule* set out in the Schedule to these Regulations. Schedule.


