**FIRST SCHEDULE**

**ALL THAT** land the property of Friendship Farms Limited situate at Waterford in the parish of Saint Michael in this Island, containing by admeasurement 61.97 hectares or thereabouts Abutting and Bounding on lands of the Crown on two sides on a road known as Storey Gap on lands now or late of Friendship Plantation on lands of sundry owners on lands now or late of Beverley Catline on lands now or late of Patrick Bethel on lands now or late of the Estate of William K. Boyce and on a public road or however else the same may abut and bound as shown and delineated on a plan certified on the 23rd day of February, 2006 by Kevin Belgrave, Land Surveyor and recorded in the Lands and Surveys Department on the 8th day of March, 2006 as Plan No.247/2006.

**SECOND SCHEDULE**

**ALL THAT** land the property of Striker Limited situate at Waterford in the parish of Saint Michael in this Island, containing by admeasurement 3506.3 square metres or thereabouts Abutting and Bounding on lands now or late of Friendship Farms Limited on a public road known as Highway 3 which leads to Station Hill in one direction and to the ABC Highway in the other direction on other lands now or late of Friendship Farms Limited and on a public road or however else the same may abut and bound together with the buildings thereon as shown and delineated on a plan certified on the 27th day of February, 2005 by Kevin Belgrave, Land Surveyor and recorded in the Lands and Surveys Department on the 11th day of March, 2005 as Plan No.251/2005.

### ADDENDUM

On the 8th day of November, 2001 Cabinet agreed to the acquisition of twelve parcels of land. However, a decision was made to acquire only two parcels as specified in the Schedules hereto, one of which is the parcel of land mentioned in the *First Schedule* to this Resolution situate at Friendship in the parish of Saint Michael. On the 7th day of August 2003, Cabinet also agreed to the acquisition of the other parcel of land mentioned in the *Second Schedule* to this Resolution situate at Waterford in the parish of Saint Michael for the purpose of developing a National Botanical Garden.

The approval of Parliament is now sought for the compulsory acquisition of the parcels of land described in the Schedules hereto in order that the purpose set out in the Resolution may be effected and that the Crown may acquire an indefeasible title to the said parcels of land.
