## **FIRST SCHEDULE**

**ALL THAT** land the property of the Crown situate at Jackmans in the parish of Saint Michael in this Island containing by admeasurement 483.02 square metres or thereabouts Abutting and Bounding on lands now or late of the Estate of Eustace Forde deceased, on lands now or late of the National Housing Corporation on lands now or late of Jeffrey Fields and on a public road which leads to Hothersal Turning in one direction and to Canewood in the other direction or however else the same may abut and bound as shown and delineated on a plan certified on the 18th day of December, 2000 by Leandre A. Murrell, Land Surveyor and recorded in the Lands and Surveys Department on the 9th day of January, 2001 as Plan No. 25/2001.

## **SECOND SCHEDULE**

**ALL THAT** land the property of the Crown situate at Jackmans in the parish of Saint Michael in this Island containing by admeasurement 998.90 square metres or thereabouts Abutting and Bounding on lands now or late of the Estate of Beatrice Belle deceased, on lands now or late of the National Housing Corporation on lands now or late of Marie Thompson and on a public road which leads to Hothersal Turning in one direction and to Canewood in the other direction or however else the same may abut and bound as shown and delineated on a plan certified on the 18th day of December, 2000 by Leandre A. Murrell, Land Surveyor and recorded in the Lands and Surveys Department on the 9th day of January, 2001 as Plan No. 24/2001.

## **ADDENDUM**

On the 29th day of March, 2001 the Cabinet agreed that the parcels of land described in the Schedules to this Resolution should be acquired for the construction of an access road to the National Housing Corporation Development.

The said parcels of land were acquired on the 18th day of July, 2002 in accordance with the *Land Acquisition Act*, Cap. 228 as evidenced by Statutory Instrument No. 80 of 2002.

In accordance with the provisions of section 5 of the *Crown Lands (Vesting and Disposal) Act*, Cap. 225, the approval of Parliament is now sought for the vesting in the National Housing Corporation of the parcels of land described in the Schedules to this Resolution.
