PLANT PROTECTION BILL, 2023

On the Order being called for Senator Dr. the Hon. S. M. Munro-Knight to move the second reading of the Bill entitled an Act to provide for the protection of plant resources by preventing the introduction plant pests and controlling the spread of plant pests in order to facilitate the trade in plants and plant products in accordance with the obligations under the World Trade Organization Agreement on the Application of Sanitary and Phytosanitary Measures, the International Plant Protection Convention and the International Standards on Phytosanitary Measures; and for related matters,

the Hon. Member spoke and moved that the Bill be read a second time.

- (Clauses 32 to 44); Part 6 (Clauses 45 to 49); Part 7 (Clauses 50 to 62) and Part 8 (63 to 68) were called and passed on the separate motion of Senator Dr. the Hon. S. M. Munro-Knight.
- On the motion of Senator Dr. the Hon. S. M. Munro-Knight the Chairman of Committees reported the passing of the Bill in Committee to the President who resumed the Chair and reported accordingly.
- On the separate motion of Senator Dr. the Hon. S. M. Munro-Knight the Bill was read a third time and passed and the title read and agreed to.
