In accordance with the provisions of section 5 of the *Lands Acquisition Act*, Cap. 228, the approval of Parliament is now sought for the compulsory acquisition of the parcels of land described in the *Schedules* hereto in order that the public purpose set out in the Resolution may be effected and that the State may acquire an indefeasible title to the said parcels of land.
